Vet Notes: Weight 58.8 lbs Diet: Blue buffalo - chicken based diet Flea/Tick Prevention: Advantage II Heartworm Prevention: Heartgard Plus S: Foster Owner noted P has been scratching at ears and head shaking. Does also scratch and chew on paws / flanks / body. HX of dermal neoplastic masses that have already been SX removed (O unsure of dx) and CCL injuries to both stifles. No C/S/V/D. Normal E/D/U/A. O: BAR M/M - pink. BCS: 3.5/5. Hyd. EENT -OU - NSF RIGHT ear - large amount of dark brown debris with mild erythema. After multiple flushing canal is mildly stenotic - partial view of TM: NSF. LEFT ear - Canal open and comfortable. TM - NSF. Distal tip of pinna is split and actively bleeding (approx 1 cm in length). Oral - NSF CardioPulm - NSF Skin - Lacerate distal tip of Left pinna, x 4 paws mild erythema with crusting dark brown debris around the nail bed with slight/mild salivary staining on the ventral aspects of paws, multiple dark red/brown color dermal masses on the inguinal with a moderate SQ mass mid-prepuce, partial alopecia on base of tail, moderately pruritic - worst on flanks. No visible flea or flea dirt seen (was recently bathed). MS - Bilateral stifles are crepitus on flex/ext - L > R. Bilateral front paws digits 3/4 ground down very short to nail base. Abd - Soft, nonpainful. PLN - NSF Rectal - moderate sized A/G - normal d/c. A: Otitis ext, lacerated pinna, pododermatitis, CCL injuries with crepitus stifles, pruritic dermatitis, Dermal and SQ masses. P: Ear cytology = neg A.U. nail bed cytology = neg [x] Clipped and cleaned pinna laceration - attempted hemostasis with Silver Nitrate sticks and tissue glue. RX (OUT) - Cephalexin 250 mg capsules #20 - give 1 capsule by mouth twice a day (every 12 hours) for 10 days WITH Cephalexin 500 mg capsules #20 give 1 capsule by mouth twice a day (every 12 hours) for 10 days. \*\*Give with food. No Refills - MLL RX (OUT) - Hydroxyzine HCL 50 mg tablets #45 - Give 1 and 1/2 tablet by mouth q 12 - 24 hours as needed for allergies. Refills avail 1 year - MLL DISP - Mal-A-Ket Plus Triz EDTA Otic flush - \*Shake well before use. Flush right ear once a day for 7 days than for both ears as needed post-swimming and bathing. Refills avail 1 year - MLL \*May need to wait 1 week to allow LEFT ear flap laceration to heal before continuing treatment of the RIGHT ear - since head shaking is expected after ear flushing since continued trauma to ear tip will delay healing. R/ Diet change to Novel LID Ingredients R/ Continue joint supplement, fish oil, weight loss for comfort of knees. R/ FSV to work up masses on abdomen/inguinal. R/ Flea and TICK prevention.
